The hotel is located at 2 soi1, Nawatgate Road, Tambon watgate, Muang Chiang Mai 50000 Tel. 0 5324 7788 Both agencies have agreed to have cooperation for vocational education in order to produce and develop manpower in the area of vocational education, develop curriculum, teaching and learning in vocational education to meet the requirement of the labor market. Therefore, the signatory agencies have agreed to have cooperation for developing potential of vocational education as in the following details.

#### No. 1 Objectives

1. To strengthen and develop network system of mutual cooperation for vocational education with workplaces and organizations in Chiang Mai Province.
2. To have mutual cooperation for producing and developing manpower in the area of vocational education in terms of quantity and quality to have vocational skills and characteristics that is ready to enter the labor market and professional market.
3. To develop a learning and teaching curriculum to be a competency- based curriculum to meet requirements of the workplace and labor market.
4. To use educational resources together and to promote the careers of the students of the college, the personnel of the workplace, and the general public.
5. To have mutual education management in terms of DVT (School – Factory), admission of job training students, development of workplace's personnel and others according to consent of both agencies.

## No. 2 Scope of Management

2.1 Chiang Rai Vocational College is responsible for the management of vocational education and professional training in order to produce and develop manpower in the area of vocational education.

2.2 137 Pillars House Chiang Mai is responsible for coaching and training to develop the potential of manpower's skills to be accepted by the labor market both at home and abroad including curriculum and personnel development.

## No. 3 Cooperation activities

Chiang Rai Vocational College in collaboration with 137 Pillars House Chiang Mai to develop vocational education in accordance with government cooperative system as follows.

1. Plan and develop vocational education in the level of skilled workers, technicians, and technologists.
2. Appoint a working group responsible for management includes representatives of Chiang Rai Vocational College and representatives of 137 Pillars House Chiang Mai have a responsibility to organize events according to collaborative approach for the benefit of education and society

## No. 4 Signing of Cooperation

In order to indicate intention on working according to this memorandum of understanding. Both cooperative agencies jointly sign the memorandum on the **12 January 2017**. The agreement shall be effective on the signing date. It will be valid for a period of **3 years**. However this agreement may, at any time during its period of validity be terminated by either institution by giving 3 months prior notice to the other in writing.
